- Use of panel discussion for Helena Jackpot show- *People from the outdoor explained that the Helena Jackpot show has been using the panels and building for the show in the past. - Karen made a motion that the Helena Jackpot Show can only use the front of the BHB Friday, June 9th and have access to the back of the BHB for panel access only with no animals. Lori 2nd the motion. All were in favor and the motion passed.
- *Katie made a motion that the Helena Jackpot Show is not allowed to use the 4-H scales. Karen 2nd the motion. All were in favor and the motion passed.*
- Katie made a motion that the Helena Jackpot Show is not allowed to use the 4-H sound system. Vanessa 2^{nd} the motion. All were in favor and the motion passed.
- Chris made a motion if the council consults the outdoor committee on a price for the panel rental and facility that will be \$1,500 per day (June 9, 10,11). Lisa 2nd the motion. All were in favor and the motion passed.
- Dog Schedule Change- Lori brought up that she has 27 dogs doing dog agility and that 5 hours is not enough time to fit them all in without pushing back the goat and dairy show. She suggested that her 15 brand new dogs that are in level 1 do their show on July 15th and the 12 dogs that are in level 2 and 3 still go on the scheduled date. All were in favor or what Lori suggested and to move forward with the schedule she wants.
